FY 2024 HMIS Data Standards

HUD has released the <u>FY2022 HMIS Data Standards Manual</u>. These changes will be implemented in HMIS as of October 1st, and include updates for the projects below.



HMIS Project Update Forms

HMIS Consent to Share Protected Personal Information

The <u>HMIS Consent to Share Protect Personal Information form</u> is updated. This form will be updated on a quarterly basis to include the updated list of agencies participating in HMIS.

Please note that the list of entities contributing data to HMIS can change frequently and without notice, and therefore the website should be consulted for the most recent list.

Program Move

A Program Move is used when you have mistakenly enrolled a client in the wrong program.

Note: If the client was provided services with funds for that program, the client cannot be moved. They must be exited and enrolled in the new program. Services from the old program are moved to the new enrollment however the names of the services will match that of the old program. Notes will be moved to the new program.

- To resolve: Submit a ticket to the Helpdesk to request a client move from one program to another.

Project Performance Report

The <u>Street Outreach Project Performance Report</u> has been published. The <u>Homelessness Prevention Project</u> <u>Performance Report</u> will be published Thursday, September 14th. Please review the <u>Project Performance</u> <u>Report Overview</u> for applicable goals.

Keep an eye out for the Permanent Supportive Housing & Other Permanent Housing PPR Goal 10 Draft data in DropBox and also run the Project Performance Reports in Clarity to review the additional goals.

Please refer to the <u>FY2024 HMIS Data Standards for additional guidance</u> on the data elements.

- Q: Will partial or approximate Social Security Number cause a data error?
 - A: <u>PATH, CoC, and ESG Program-funded projects</u> are only required to collect the last four digits of the SSN, though are not prohibited from collecting all nine digits. CoC and ESG-funded projects are not penalized for only collecting the last four digits of the SSN.

When enrolling a client who already has a record in the HMIS, verify that the SSN in the system is accurate and correct it if it is not. **Do not replace a 9-digit SSN with the 4-digit SSN on existing clients unless the client has requested this.**

- Q: What are the options under the combined Race & Ethnicity drop down?
 - A: The response option for "Middle Eastern or North African" and "Hispanic/Latina/e/o" was updated. There is also a text box to add detail. Please review the <u>manual</u> for the full list.
- Q: For these changes to data fields, will we be getting updated forms?
 - $\circ~$ A: Yes the forms will be updated with the new data standards.
- Q: What is the date the new Data Standards effective?
 A: 10/1/2023
- Q: How do I answer if a client is fleeing domestic violence in jail or would it be classified assault?
 - A: The client would not be classified as DV survivors unless the situation included someone within their household/partnership.
