Quarter 4 Data Quality Report Card

The <u>Quarter 4 Data Quality Report Card</u> will be published soon. The HMIS Helpdesk will send out a newsletter with a link to the report card once it is published.

The Data Quality Report Cards look at the following:

- Data Completeness
- Data Accuracy
- Data Timeliness

The report card has a slicer tool which allows agencies to review their data as a whole. The project-level slicer tool is still available for agency's use.

The UDE Data Completeness Dashboard, and the Timeliness Dashboards also include the Agency and Project Name filters.

CoC Dashboard

The CoC Dashboard contains information about clients who were active in any HMIS project type, or who contacted 211OC for information and referral during the reporting period.

The CoC Dashboard is updated on a quarterly basis. The Quarter 4 dashboard : **October - December 2024** is now available.

Monthly Report Highlight

The <u>Client Demographics Report [OUTS 106]</u> is a program-based report that provides client demographic details for selected programs for a specified range of time. All users can run the report but are only able to select from projects set-up under their agency.

The Client Demographics Report pulls data from two places in the client record: The client profile screen and the program enrollment screen.

To access and run the report:

- Go to the Report Library by clicking the launch pad icon at the top right of the screen, select Reports.
- Select the drop-down for Program Based Reports.
- From the list of Program Based Reports, find [OUTS-106] Client Demographics [Program Based] > 'RUN.'
- This will take you to the report screen where you will enter the search parameters.

Then, set the appropriate parameters for the report by selecting the following:

- Project(s) Type For multiple projects Ctrl + select*
- Program Status
- Program(s) available to your agency*
- Veteran Status
- Client Project Stay Type
- Report Date Range
- Report Output Format
- Click submit to run Report.

The Client Demographics Report will display results as charts and graphs. Each graph is accompanied by a table for that demographic category.

Users may utilize the drill down feature by clicking the numerical results in the "# of Clients" column to generate a list of participants counted in that category.

Project Performance Report

The Project Performance Report (PPR) for Street Outreach will be published on the OC HMIS website in the upcoming weeks. Current and past PPRs can be found on <u>our website</u> by navigating to:

Corrections for the Homeless Prevention PPR draft data will be uploaded into DropBox in the upcoming weeks.





The <u>Project Performance Overview</u> is a helpful document which provides important information regarding the PPRs including the thresholds for each goal and our publishing schedule.
